RETIREE COLA SET FOR 2016

2016 will be the first year since 2011 that Military and federal civilian retirees, survivor benefit annuitants, disabled veterans and Social Security recipients do not receive a cost of living adjustment (COLA). In 2010 and 2011 there was also no COLA. The reason why federal retirees will not receive a COLA in 2016 is that consumer prices have declined over the past year. The annual retiree COLA is calculated as the change in the average Consumer Price Index for Wage Earners and Clerical Workers (CPI-W), published by the Bureau of Labor Statistics (BLS), from the third quarter of the previous year to the third quarter of the current year. BLS reported that the (CPI-W) actually decreased from the third quarter of 2014 to the same quarter of 2015.

ELECTIONS

A reminder that elections for Commander and Secretary/Treasurer will be held at the next reunion. Yeo and I are running, actually just walking sort of, again. PHONE CALLS

VA HEALTH CARE SYSTEM

An independent report on the Department of Veterans Affairs health care program (Veterans Health Administration-VHA) concludes that the system needs a complete overhaul. This report was mandated by Congress last year. It shows that the system suffering from bureaucracy and leadership challenges, and is on an "unsustainable trajectory of capital costs." Many veterans have complained that the VHA is difficult to navigate and that the quality of care varies from location to location. This report confirms that observation. The report notes a lack of leadership at VA, a staffing shortage, and a demoralized workforce. VA Secretary Bob McDonald agreed with many of the findings of the report and noted "VA is undergoing a radical transformation." The report noted that VA outpatient care outperforms other health care systems.

DEAL LIFTS DEFENSE SPENDING, EXTENDS DEBT CEILING AND STOPS MEDICARE PREMIUM INCREASE

House leadership and White House staff reached an agreement on the FY 2016 and FY 2017 budget limits that would, for a two-year period, exclude Defense from sequestration cuts mandated by the Budget Control Act (BCA) of 2011. In addition, the agreement lifts the debt ceiling for the federal government until March 31, 2017. The agreement also prevents a 52-percent increase in Medicare premiums for 30 percent of Medicare recipients. The premium increase would fall on 30 percent of beneficiaries. This includes more than eight million low-income seniors enrolled in both Medicare and Medicaid, new Medicare enrollees, and higher-income beneficiaries.

The agreement would also avoid across-the-board Social Security Disability Insurance benefit reductions. The measure (H.R. 1314) had to pass by Monday, November 2, to avoid a first-ever government default on the debt payment.

VA OFFICIALS REFUSE TO TALK

The House Veterans Affairs Committee (HVAC) finally got the five Department of Veterans Affairs (VA) witnesses they demanded last month. However, the witnesses did not provide any new information on the VA's relocation bonus scandal.

The controversy centers around two officials who refused to answer any committee questions on their alleged schemes to game the bonus program for personal gain, instead they invoked their Fifth Amendment rights against self-incrimination. Three other VA officials also subpoenaed by HVAC described a flawed employee reassignment process but not a corrupt system, which several lawmakers have accused top VA officials of allowing to fester.

"If I could go back in time, I still would have made all the moves," said VA's acting Undersecretary for Benefits Danny Pummill. He blamed the "second and third order" problems of the bonus program on the VA moving too quickly to get the right people in posts that needed immediate improvements, to better help veterans. The VA Office of the Inspector General investigation discovered that some senior VA executives misused interoffice moves to bump up their pay while reducing their job responsibilities, at a significant cost to taxpayers. The Veterans Benefits Administration (VBA) spent more than \$1.5 million on 21 questionable senior executive reassignments over the past three fiscal years. The investigation was spurred by two specific cases. Philadelphia VA Regional Office Director Diana Rubens is blamed for receiving more than \$288,000 in moving expense compensation to switch from a job in nearby Washington, D.C. and St. Paul, Minnesota, VA Regional Office Director Kimberly Graves received nearly \$130,000 in a similar job switch scheme. Both officials were required to appear before HVAC, and both refused to answer any questions on the advice of their lawyers.
