# VA EXPANDS CHOICE PROGRAM ELIGIBILITY

The Department of Veterans Affairs (VA) has announced that it will change the geographic calculation used to determine the distance between a veteran's home and the nearest VA medical facility for purposes of the Veterans Access, Choice and Accountability Act (VACAA), which took effect on November 5, 2014. The VA will make a regulatory change from straight line distance to driving distance to help ensure veterans have more access to care.

VACAA was signed into law by the president last year. The new law provides a \$10 billion fund to pay for non-VA care for veterans who live 40 or more miles from a VA facility or have been experiencing wait times for care of more than 30 days. VA mailed "Choice Cards" to veterans who were enrolled in VA health care as of August 1, 2014, and to recently-discharged combat veterans who enroll within the five-year window of eligibility.

# VA ELIMINATES NET WORTH AS VETERAN HEALTH CARE ELIGIBILITY FACTOR

The Department of Veterans Affairs is updating the way it determines eligibility for VA health care. This is a change that will result in more Veterans having access to the health care benefits they've earned and deserve. Effective 2015, VA eliminated the use of net worth as a determining factor for both health care programs and copayment responsibilities. This change makes VA health care benefits more accessible to lower-income Veterans and brings VA policies in line with Secretary Bob McDonald's MyVA initiative which reorients VA around Veterans' needs.

"Everything that we do and every decision we make has to be focused on the Veterans we serve," said Secretary Bob McDonald. "We are working every day to earn their trust. Changing the way we determine eligibility to make the process easier for Veterans is part of our promise to our Veterans."

Instead of combining the sum of Veterans' income with their assets to determine eligibility for medical care and co-payment obligations, VA will now only consider a Veteran's gross household income and deductible expenses from the previous year. Elimination of the consideration of net worth for VA health care enrollment means that certain lower-income, non-service-connected Veterans will have less out-of- pocket costs. Over a 5-year period, it is estimated that 190,000 Veterans will become eligible for reduced costs of their health care services.

In March 2014, VA eliminated the annual requirement for updated financial information. VA now uses information from the Internal Revenue Service and Social Security Administration to automatically match individual Veterans' income information which reduces the burden on Veterans to keep their healthcare eligibility up to date. That change better aligned VA's health care financial assessment program with other federal health care organizations.

#### **HOSPITALITY ROOM**

The hospitality room is on the ground floor and has a terrace so we can enjoy the outdoors or indoors. It is close to the pool, spa, and exercise room. This will interest all as we attempt to work off all the free beer. Since a breakfast is included, we will not have sticky buns in the hospitality room this time but we will have Seattle's Best coffee. As always free beer, soft drinks, and water will be available. There are very large parking areas on three sides of the hotel. The parking areas are large enough to allow us to park EMPTY RV's. Remember, the hotel is in business to rent rooms so no living in the RVs in the parking lot. Later I will print information on RV parks in the area and close to the hotel. We don't want any of the RVers to get lost to or from the hotel

#### **HOTEL SHUTTLE**

The hotel provides a free shuttle to and from any place within three miles of the hotel. This is great for dinner or tourist activities. The shuttle to and from the airport is \$15.00 for one person and gets cheaper for each rider with more people. Cabs are \$45.00 to or from the airport.

## **GOLF COURSES**

There are several golf courses in Tucson. There is one next door to the hotel and they will give us a discount because we are such nice guys. The final decision will be made later.
